Dear 4-H Families:

Congratulations and thanks to the 14 high school counselors who did a great job of leading their campers at this year's "Spy Academy" themed summer camp. For three days 65 campers in grades 3-8 participated in a wide range of educational activities, recreation, and fun at Pigeon Lake Camp in Drummond, led by the counselors and adult staff and volunteers.

To establish shared expectations, camp counselors are trained to introduce and uphold the ARCH, a model which is used both at camp and on Bayfield County 4-H expectation forms to create shared expectations for behavior and working together successfully as a group.

The ARCH stands for the values **Accountability, Compassion, Respect, and Honesty**. The fifth piece, or "keystone" to the ARCH is everyone's **commitment** to applying all of these values at the same time.

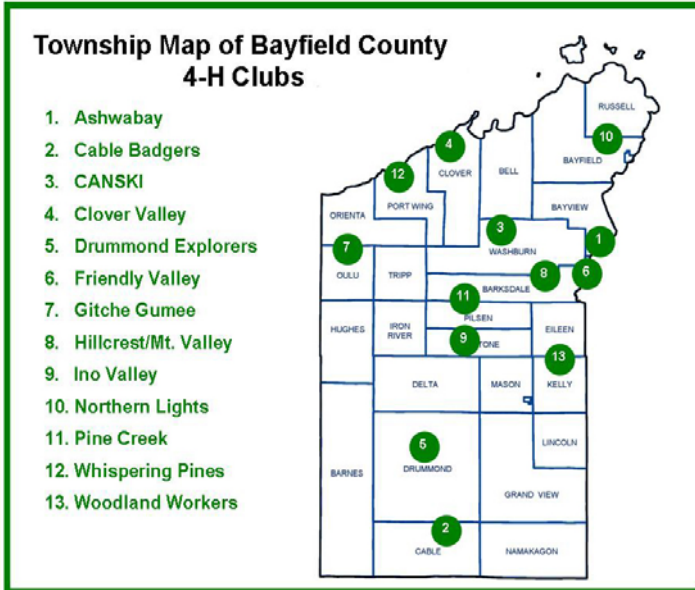

We will be tie dying and fabric painting them. Our next meeting will be July 17th.

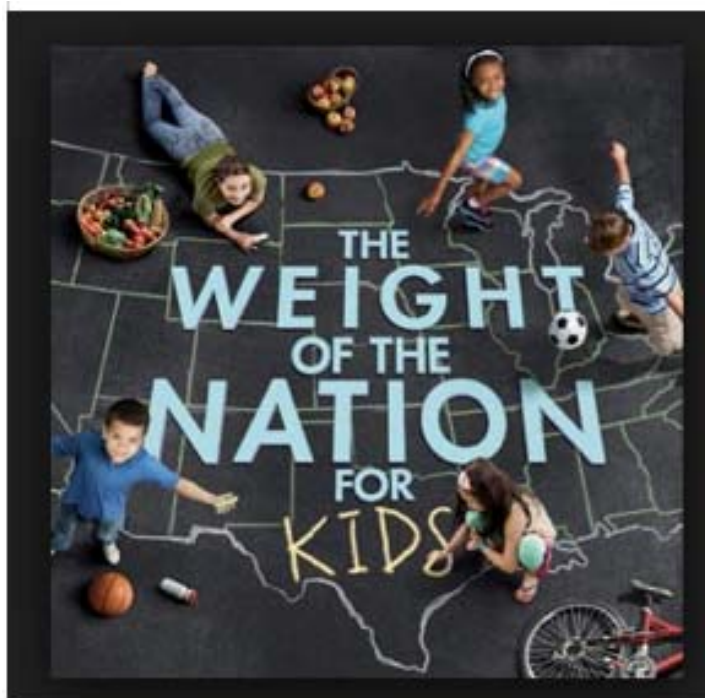

Older Member Awards and Scholarships: Applications available now and due Sept 18

Bayfield County 4-H annually recognizes its older members' achievements and leadership potential through the Older Member Awards process. 4-H'ers who will be entering the 8th grade this fall (and members up to 12th grade) are eligible to apply.

This is the process through which teen members are chosen to be Ambassadors and receive scholarships for trips such as Citizenship Washington Focus, State 4-H Conference, Winter Camp, and the Bayfield County Adventure Trips.

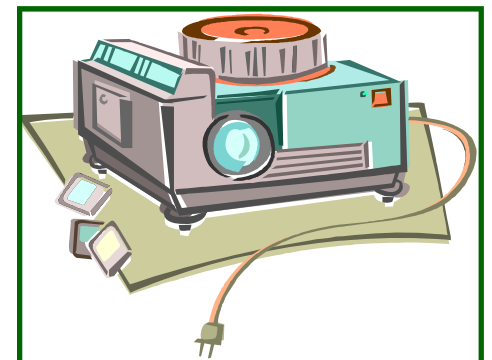


Do you have some pictures from project meetings or other 4-H events that you are willing to share?

Record Books - What are they good for?

With the excitement of the fair just around the corner, it's a good time to be thinking about how we can capture and remember all the fun things we've done this year in 4-H. Members who keep record books are able to look back at the highlights over the years and recall all their good times and accomplishments. Parents: think about these additional benefits for your child:

Record-Keeping Skills: Youth learn the importance of keeping records.

Documentation: Record books are a source of documentation for future reference. (Like the Older Member Awards application, job applications, etc.)

Growth: Record book forms allow youth to demonstrate how they have grown throughout the year.

Organization: Record books allow youth to develop good organizational methods.

Financial Records: Youth keep financial records of their project which can be a valuable asset in the future.

Goals: Record book forms encourage youth to establish their goals for

the 4-H year.

Memories: Record books are a wonderful source of 4-H memorabilia.

Responsibility: Youth practice responsible behavior by completing record books.

A record book can be as simple as completing the **Permanent Record Form** (this is where you record points that are applied to the Bronze, Silver, and Gold Achievement Awards), a **short story** about your year, and some **photos and project records** to really tell the story. It is not required that you complete records for all of your projects – maybe you just want to focus on the ones you feel the proudest of.

If you haven't started your record book yet, it's not too late! All forms are available in our office or on our website at <http://bayfield.uwex.edu/4-h-youth-development/4-h-forms/>. Get them ready, take some pictures of your project work, and complete your record book after the fair. Your club leaders will be delighted to see what you've accomplished this year!

(other than a 4-H leader), group, or
business that would be considered a
strong supporter of the Bayfield
County 4-H program presently or in
the past.

Outstanding Alumni

This award recognizes an individual
who was an active 4-H member as a
youth and who has worked with the
4-H program as an adult and made
a significant impact on the lives of
their 4-H members. The award win-
ner is recognized as an excellent
role model in the area of citizenship,
leadership, and life accomplish-
ments and character.

- ◆ **Wait to unload your animal(s) until after you have checked with the Superintendent and have shown him/her any health forms.**
- ◆ All stalls and pens are assigned by the Super.
- ◆ Park your truck and trailer in the parking lot after you have dropped off your feed and animals.
- ◆ Straw, hay & wood shavings can be used for bedding. Do not use shredded paper for bedding.
- ◆ Wood shavings will be for sale during the Fair at the Fair office.
- ◆ Keep the barns clean. This means thoroughly cleaning your stalls daily after the barns close - Not just covering things up with fresh bedding and hauling everything out on Sunday.
- ◆ **Do not eat or drink in the barns.** (For health safety reasons.) Set a good example for the Public.



- ◆ Keep your hands clean-wash them often.

When the Public leaves the barns, thank them for stopping by and remind them that there are hand washing stations and Purell dispensers near the barn exits, for them to wash their hands.

Getting to the barns ...

Again this year, there will be limited vehicle traffic allowed to the barns and camping areas. The times and gates to use are as follows:

- ◆ Thursday 11am – 8pm – Gate 3 open (between Dairy & Draft Horse barns)
- ◆ Friday- Sunday 7am-9am – Driveway access back and forth in front of office (you must park your vehicle in the main parking lot by 9am)
- ◆ Sunday 5pm-8pm – Gate 3 open

Please follow these additional rules and guidelines:

- ◆ ALL person(s) in the vehicle must have a Daily or a Season wristband.
- ◆ After you have unloaded/loaded and fed your animals; you must park in the regular parking lot. Please do not stay parked near the barns.
- ◆ Be courteous to our gate people; they are just doing their jobs.
- ◆ SLOW DOWN! If you feel like you could walk faster than what you are driving; that is the right speed!!!
- ◆ Expect the unexpected! Adults and kids don't always pay attention to what's going on around them—use caution.
- ◆ If the handicapped parking area is full (usually Sunday), the Fair Committee will designate additional handicapped parking for the public near the sheep & swine barns.

We hope you understand that we are striving to keep everyone at the Bayfield County Fair safe & accident free.

To bring your poultry or waterfowl to the Fair you must have a **Premise ID number AND** your birds must be from a **pullorum free flock or tested as pullorum free**

David Lindelof, David Grote and Katie Peltier will be holding a free pullorum testing clinic for poultry & waterfowl that will be shown in Open & Junior Class at the 2013 Bayfield County Fair. Please bring with you (or know) your Premise ID number to the pullorum testing clinic. **Turkeys will NOT be tested at this clinic.**



Birds that are going to the Fair must be individually tested if:

- You do not have an official certificate stating your birds are from or enrolled in a National Poultry Improvement Plan (NPIP) or in the WI Certified Tested Flock (WTF) or a WI Assoc Flock. (WAF) **OR**
- Your birds have been on site where older chickens (wintered over from last year) are located, regardless of certification or age.

- ♦ You MUST get a camping permit from the staff at the Fair Office. They will be available on Wednesday from 2pm—7 pm and Thursday starting at 9:30 am.
- ♦ Place your camping permit in a visible spot.
- ♦ Primitive camping with horses should be set up in the designated "Horse Camping" areas only. Near the Horse Trailer parking - SE of the Diamon (Green) Horse Barn.
- ♦ Remember to use "common sense" and "common courtesy" when setting up your campsite.
- ♦ No generators are allowed in the primitive camping areas.
- ♦ Anyone under the age of 18 must be camping with a responsible adult.
- ♦ Please follow all of the Camping Rules. For more details check the Fair website.
