

What is the ADRC of the North and How Do I Get Their Help?!?



ADRC stands for **A**ging and **D**isability **R**esource **C**enter and every county in the state of Wisconsin has one, or in less populated counties, like Bayfield County, they share a regional ADRC with neighboring counties.

Bayfield County is part of the ADRC of the North, which is a regional ADRC that covers the five-county region of Ashland, Bayfield, Iron, Price and Sawyer Counties.

The ADRC of the North – Bayfield County branch, is here to help Bayfield County older adults and people with disabilities and the people who support them. People call the ADRC with all kinds of questions they need answers to.

An ADRC gives FREE and
UNBIASED information
about getting older or living with a disability to
anyone with questions about the things and
services needed to live safely. This means you
can trust the information you receive from the

ADRCs serve the following Wisconsin residents regardless of income:

Older adults

ADRC.

- Adults with physical disabilities
- Adults with intellectual or developmental disabilities

- Youth with disabilities transitioning into the adult services system (over 17 ½)
- Caregivers, family members, guardians
- Healthy adults planning for the future
- Professionals

ADRC staff provide support and guidance to those seeking help. They know local agencies and resources that are available to customers. THE ADRC staff includes:

- Information and assistance specialists provide unbiased information related to aging or living with a disability.
- Options counseling explore options available to meet long-term care needs.
- Dementia care specialists provide support for people with dementia and their families.
- Benefit specialists provide confidential advice about programs and benefits including FoodShare, Medicaid, Medicare, private health insurance, and Social Security.
- Disability benefit specialists help adults with disabilities who are between the ages of 17 ½ and 59.
- Elder benefit specialists: help adults who are 60 or older.

We Are Here To Help

Dementia Care Specialists: Providing Education and Support to Individual, Families, and the Community.

Dementia-Capable WISCONSIN

The state of Wisconsin is

believed to be a trend setter as we are one of the few states that employ Dementia Care Specialists (DCS), through the Aging and Disability Resource Center, in each county. The role of a DCS is to provide support for those living with dementia, provide education to encourage inclusive communities, and to provide caregiver support. This is all done at no cost to those wanting services - removing the financial barrier so that all community members are able to utilize this resource and have access to information.

"Help! I am a caregiver- how can the DCS help me?"

The DCS can answer your questions about dementia and provide you with education and training. They also can help you address your current situation and plan for the future. The DCS also runs educational programing specific to caregivers- classes like "Powerful Tools for



Caregivers" is a 6-week class (held virtually) where caregivers learn best practices to interact with

their loved ones living with dementia. Caregivers learn tools to not simply "survive" the experience, but help them thrive in the caregiver role.

"Help, I have recently been diagnosed with dementia, what do I do now?"

A simple call to the ADRC at 1-866-663-3607, and you can ask to be referred to the DCS to begin the partnership.

The DCS will help you understand your diagnosis, teach you how to maintain independence as long as possible, talk about research studies, and plan a path forward- all of which can be done, in the comfort of your own home. The DCS will come right to you!

Another service the DCS provides is cognition screening- these screens are brief, non-diagnostic tests that are used to evaluate memory, judgement,

and the ability to understand visual information. Cognition screens provide results in minutes allowing you to track your performance on screens over time- this will help you see how your cognition is changing through the course of the disease. This tool also provides individuals with talking points to aid a discussion between you and your physician regarding your cognitive health.

"Help! I am a community member/ business owner who wants to be supportive and inclusive to community members living with dementia – How can a DCS help me?!"

Dementia-friendly communities are places where people living with dementia are safe, respected, and supported. The DCS works to increase civic awareness toward dementia, create dementia networks and host a variety of events that promote socialization in public spaces with others.



Most commonly, the DCS offers "Dementia Friendly Business Training"; which is a 60-minute training that helps business better serve and support people living with dementia and their caregivers.

The DCS also hosts programs, such as "Dementia Live", which is a simulation experience open to community members. During "Dementia Live", participants receive a brief overview of dementia and then experience a simulation meant to dampen senses in a way that mimics dementia. This experience is thought to build empathy among participants as well as provide education as to what dementia is and how it effects our immediate community.

HANDICAPPED ACCESSIBILITY

Funds may be used for accessibility modifications to a dwelling unit occupied by a Low to Moderate Income (LMI) person who is physically handicapped. Typical modifications include ramps, grab bars, accessible shower stalls, wider doorways and hallways, and the installation of door handles, in place of doorknobs.

RENTER-OCCUPIED REHABILITATION

The program may provide funds for the rehabilitation of LMI renter-occupied units with zero percent interest, installment loans. Landlord must be the one to first apply and approval is based on renters' income and rental terms.

OWNER-OCCUPIED REHABILITATION

The program provides rehabilitation assistance to LMI owner-occupied housing units. Financial assistance to eligible owner-occupied households is in the form of a zero percent interest, deferred payment loan, secured by a mortgage until the unit ceases to be the borrower's principal place of residence. The property must be titled in the owner's name, taxes must be current, and the property must be insured against direct loss or damage. Homes under life estates and land contracts are eligible.

Disability Benefit Specialist



A Disability Benefit Specialist provides free confidential services to individuals ages 18 to 59 with a physical or developmental disability, mental illness, or substance abuse disorder.

A Disability Benefit Specialist can answer questions related to Social Security, Medicare, health insurance, and/or other public and private benefits. They also assist those who have barriers to access benefits for which they are eligible.

A Disability Benefit Specialist can:

- programs or services that might best meet your needs.
- Help determine which benefits and programs you may be entitled to.
- Provide referrals, assistance and support on other matters including disability rights and the impact of earnings on financial eligibility for public benefits.
- Help you to fill out applications for benefits, programs and services.
- Help you fill out appeals for Social Security and State benefits.



Medicare 101 Virtual Informational Meetings in 2025

The Bayfield County Elder Benefits Specialist, Marianne Johnson will be offering "Medicare 101" presentations for those Bayfield County residents who are approaching age 65 or who will soon be on Medicare.

These presentations will introduce attendees to the basics of Medicare, as well as give you the information you need to know before making decisions about enrolling in Medicare Information provided will help you understand which Medicare options would best suit your needs The Elder Benefit Specialist is an unbiased source for information and helps people get the information they need to make an informed decision about benefits.

If you are turning 65 this year and a Bayfield County resident, attending one of these presentations is required before a one-on-one meeting will be scheduled to review individual **Medicare options**

Due to an increasing need for assistance, it is no longer possible to meet with the Elder Benefits Specialist to get basic Medicare information individually. You will be required to attend a Medicare 101 training or watch a taped training available on our website prior to any personal appointments.

Recorded Medicare 101 presentations are available at: www.bayfieldcounty.wi.gov/982/Medicare-Help-Page Attending a Medicare 101 presentation will give you

enough information to understand your Medicare options and be ready to make decisions about your Medicare when it is time to do so. If you are not a Bayfield County resident you are welcome to attend the presentation but will be encouraged to contact your county's Elder Benefits Specialist as a resource.

Presentations will either start at Noon or 6:00pm and will last about an hour and a half depending on the questions asked by the audience. Please register as soon as possible in advance as there are written materials that will need to be mailed or printed off by the attendee. There is no charge for the presentations.

Accessing Wisconsin's Publicly Funded Long-Term Care Programs: Family Care and IRIS

Wisconsin has long been committed to providing comprehensive care and support for individuals in need of long-term care services. Wisconsin's commitment to providing long-term care services is exemplified through the Family Care and IRIS (Include, Respect, I Self-Direct) programs. These publicly funded initiatives ensure eligible individuals receive the necessary support for a fulfilling life.



Family Care is a publicly funded long-term care program designed to assist adults with physical disabilities, frail elders, and individuals with developmental disabilities. Its primary objective is to empower participants to live independently within their own homes and communities. Family Care, which would be managed by the client's

chosen Managed Care Organization, offers a wide range of services including: personal care, medication management, transportation, and, home modifications. By providing comprehensive support, Family Care enhances the well-being and quality of life of its participants.



IRIS, on the other hand, is a unique self-directed program. IRIS enables eligible individuals to have greater control over their care by allowing them to manage their own budgets and choose their preferred support providers. This approach empowers participants to tailor their care plans in a way that best suits their individual needs and preferences. From personal care to assistive devices and

community-based activities, IRIS offers flexibility and autonomy in decision-making.

The Family Care and IRIS programs have financial and functional eligibility. Eligibility for Family Care and IRIS can be determined by contacting the Aging and Disability Resource Center (ADRC) of the North at 1-866-663-3607. This resource hub serves as a crucial point of contact for those seeking access to long-term care services, both publicly and privately funded.

By reaching out to the ADRC of the North, individuals seeking assistance can weigh their long-term care service options including:

- Information about the choices you have when making decisions about: where to live, what kind of help you need, where to receive that care and help, and how to pay for it.
- One-on-one consultation to help you think through the pros and cons of the various options considering: your situation, values, resources, and preferences.
- Information about Wisconsin's long-term care programs and help to understand resources in your area.

Remember, you don't have to face the challenges of long-term care alone – the ADRC of the North is here to help you every step of the way. Contact the ADRC of the North at 1-866-663-3607.





The ADRC Serves Young Adults too!

Youth Transition Services

Graduating high school is a very important milestone for all students. This is especially true for students with disabilities as they move from high school to adult life.

These questions are part of the transition planning process.

- What options and supports are available for students after high school?
- How do students plan for going to work, independent living, and post-secondary education and training?

The Aging and Disability Resource Center of the North assists disabled youth with the transition to adulthood starting at 17.5 years of age and offers a single-entry point for information and assistance on issues affecting students and adults with disabilities regardless of income.

Services Provided at the ADRC include but are not limited to:

- Help applying for benefits or dealing with a denial of benefits
- Disability benefits counseling
- Information and access to publicly funded long term care programs and options counseling, if eligible
